From Granada Airport

- **Bus:** after each flight a bus is waiting for the passengers; it takes 30-40 min to go to Granada and costs 3 €. You should get off the bus at the Cathedral stop and take a taxi or the bus C2.
- **Taxi:** from the airport, it should cost 30 to 40 €.

From Málaga Airport

- **Bus:** from the airport, you can take a bus direct to Granada; if you losted it, take a cab to the bus station downtown.
